# Waiver Program

# Nursing Home Transition and Diversion (NHTD) and Traumatic Brain Injury (TBI) Waiver

People with disabilities, seniors and those with TBI experience life altering physical and/ or cognitive disabilities which may include behavioral or emotional issues. The goal of waiver program is to enable participants to live in the community with available services instead of living in a nursing home.

Sunshine Homecare Services is a NYS Dept. of Health approved provider of NHTD and TBI Waiver Services. These programs provide eligible individuals with supportive services that assist them to remain at home or transition from a nursing home.

## Service Coordination (SC)

Assisting individuals obtain and coordinate necessary services that allow them to live in the community.

# Independent Living Skills Training (ILST)

Provides training focusing on increasing independence with acquisition of practical skills such as cooking, shopping, budgeting, home organization.

# Structured Day Program (SDP)

Provides task and socially-oriented group activities designed to increase independence in a site or community setting.

# Community Integration Counseling (CIC)

Personalized assistance to encourage the acceptance of altered abilities, revised expectations, or changing roles relating to significant others.

# Positive Behavioral Interventions Supports (PBIS)

Interventions provided to individuals whose significant maladaptive behaviors, if continued, would result in them being removed from the community.

# Home and Community Support Services (HCSS)

Provides oversight and supervision to individuals with cognitive issues and assistance with daily activities such as bathing, dressing, laundry, cooking, shopping.
